#### A. Officer Kamali'i, HPD Lower Puna Liasion:

Our park is a private park and state and county laws do not apply. Most community parks are enclosed as opposed to our park being open. Therefore it is harder to enforce county ordinances and private rules. Officer Kamali'i is aware of the castle situation. He has told all his officers not to call in on the radio when they are coming here. Puna is the busiest district in the state so they have to prioritize calls. Please call because these calls have to be documented and this creates a paper trail. Neighborhood watch is a good idea and there are different type: one person runs everything, or co-coordinators, or you can have a structured one with a treasurer and secretary. It can be a foot or motorized patrol, or assigned to individual block by block. Officer Kamali'i would work with the coordinator(s). We need to post park rules and make visible. Police cannot give citations for camping or enforce hours because it's a private park. They can help mediate and ask people to leave as long as the rule and hours are posted.
